

**Do you want to schedule an appointment to receive Behavioral Health Services?** If so, just call any Pathways office and speak with one of our Access Center therapists who will help arrange a time for you to come for a Behavioral Health Assessment.

You will be asked some basic questions in order to connect you with the proper service. The Access Center Therapist will either **schedule you an appointment**, or **let you know when each of the Outpatient Offices have Open Access Times**.

**What are Open Access Times?** Open Access times are blocks of time which the Outpatient Offices will be conducting Behavioral Health Assessments. These operate on a first come, first serve basis. But for individuals who prefer not to wait a week or so for an appointment time, Open Access may be a better option.

As of January 2017, the **Open Access Time Slots** for a Behavioral Health Assessment are the following:
