## **Audit Findings**

## **Audit Narrative**

The Prison Rape Elimination Act (PREA) on-site audit of the Morehead Inspiration Center (MIC) was conducted on August 1-2, 2018, by Bryan K. Henson, a DOJ Certified PREA Auditor with one support staff, Joseph Z. Martin, also a DOJ Certified PREA Auditor. This will be the second PREA audit for MIC. The purpose of the audit was to determine compliance with The Department of Justice (DOJ) PREA standards. During the Pre-audit phase, much of the file review was conducted prior to the onsite visit with some follow-up questions provided to the PREA Coordinator. During the on-site portion of the audit, any necessary file review follow-up was completed, we toured all areas of the facility and conducted formal staff and resident interviews. The auditors interviewed a total of 24 residents, with 24 random resident interviews, and zero targeted interviews. The facility reported there were zero residents that were LGBTI, disabled, limited English proficient, or that had reported sexual abuse at the facility. In addition, the auditors interviewed a total of 25 staff, including 9 random staff, (representing all shifts and various posts), and 16 specialized staff to include the Designee for the Chief Executive Officer, the Facility Program Director, and the PREA Coordinator. All staff that were present during the two-day on-site review were interviewed. The interviews covered PREA training, how to report, to whom to report, filing reports, available interventions, conducting interviews, evidence preservation protocol, follow up, and monitoring for retaliation.

An entrance meeting was held at the beginning of our visit with the Facility Program Director, Jason Jones, and the Nurse/Intake Coordinator Robyn Baldwin. The auditors provided an overview of the audit process. There were 89 residents assigned to the facility on the first day of the on-site review, and the facility had a designed capacity of 104. Following the entrance meeting, we toured all areas of the facility. Throughout the tour, the auditors spoke informally with both staff and residents. The auditors also observed PREA signage that contained zero tolerance language as well as information on reporting methods and access to an outside victim advocate. During the tour, it was found that audit notices were posted throughout the facility. A timestamp photo had also been provided during the Preaudit phase to confirm that the notices had been posted at least six weeks prior to the on-site review. Placement of all cameras and any potential blind areas were also noted throughout the tour. The auditors received no letters of correspondence from either residents or staff prior to or during the onsite review of the audit. In the past 12 months from June 2017 through May 2018, MIC reported there were no allegations reported of sexual abuse, and no allegations of sexual harassment at the facility.

Although the facility PREA policy covers language for all standards that have a policy mandate, it is strongly recommended that the PREA Coordinator conduct a review of the PREA policy and consider

adding additional detail to better support many of the other PREA standards to assist and better guide staff in their continuous readiness and response to allegations of sexual abuse and sexual harassment.

An exit meeting was held at the end of day two to brief the Executive Staff of the general findings of the audit to date. The site visit found the staff and residents to have a good general awareness of what PREA was about. They were very aware of reporting methods and responsibilities, as well as the means to safeguard victims of sexual abuse and/or sexual harassment. The rapport between staff and residents was excellent and it was evident the facility had a very conducive reporting environment.

## **Facility Characteristics**

The Morehead Inspiration Center is a six to nine-month residential recovery program for adult men seeking recovery from substance abuse. This is a nonprofit organization and an affiliate of the Recovery Kentucky initiative. MIC currently has 15 staff and serves a population of 104 adult men and offers four levels of recovery which incorporate a social model of recovery, peer support, accountability, daily living skills, job responsibilities, and practical living experiences. These are all components that support the safety of their residents from incidents of sexual abuse and sexual harassment. MIC also incorporates the 12 steps with Recovery Dynamics classes, and life skills classes to educate the addict/alcoholic about their disease. The facility is made up of 1 building and the housing units have 35 multiple occupancy rooms, and 2 open bay dormitories. The MIC vision is to contribute to the overall quality of life of the people we serve. Our mission is to strengthen individuals, support families, and serve communities through planning, development, coordination, and provision of effective behavioral health services as well as deliver exceptional services in a caring, professional manner.

- (b-c) Although pat-down searches were not covered in the policy, the interviews of both staff and residents support that staff at MIC do not conduct pat-down searches of residents. MIC houses male residents only. Facility reported no occurrences of strip, body-cavity, or pat-down searches.
- (d) The Pathways agency PREA policy contained language to support adequate privacy provided when residents shower, perform bodily functions, and change clothing. The policy also requires staff of the opposite gender to announce themselves before entering a restroom area or a resident's apartment. Due to the anonymous nature of this type meeting, these visitors enter from an outside entrance to the facility and exit from the same doorway and do not sign-in or provide any personal information to the residents or facility. Residents leading these meetings are part of the accomplishments of this program. The facility staff have signage in these areas and supervise the area with intermittent rounds during the meetings. After requesting guidance from the PRC auditor helpline, it was determined these individuals would be treated as visitors and not be required to have any PREA training.

(a-d) The facility provides multiple internal ways for residents to report incidents, i.e. any staff member, complaint/grievance form to be mailed anonymously, given to a staff member, or slipped under a staff member's door, etc. Residents may also report outside of the agency to the PREA Hotline that goes to the KY DOJ Investigative Branch. For those residents that first arrive at the facility, they are restricted from using the phones for the first 30 days, but an address is provided for them to write to include the Victim Advocate Services, and they have multiple other internal methods that can be used during this time period. A test call was attempted on the phone banks and it would not go through unless the resident paid for the call. After the facility contacted the phone contractor, it was corrected and checked to confirm residents could make the call without cost. Staff are required to accept reports in any form and document such reports. Staff have methods in place to privately report incidents to include the hotline. The facility program is based upon a peer support and accountability system that creates a very conducive reporting environment. This was very evident from observing the rapport between staff and residents (to include peer mentors) throughout the on-site review.

The facility does have a grievance/complaint system that allows residents to file grievances related to sexual abuse. The Pathways agency PREA policy indicates there are no timelines for any

grievances/complaints related to sexual abuse. The complaint system does not require the resident to submit it or be responded to by the alleged involved staff member. When asked, the PC responded that 3<sup>rd</sup> parties may assist in these type complaints. The policy supports an established procedure for responding to emergency grievances alleging sexual abuse. No residents were disciplined as a result of filing a complaint for sexual abuse. There were no grievances/complaints filed regarding sexual abuse within the past 12 months.

Recommend that the agency PREA policy provide more of the standard language to better support the standard.

(a) At the time of the on-site review, it was found that the Pathways agency PREA policy directs for monitoring of residents and staff who report sexual abuse and/or sexual harassment however it did not include monitoring for those who cooperate with sexual abuse or sexual harassment investigations. While on-site, the auditors were provided a revision of the policy to include monitoring for those who cooperate with such investigations therefore this section is found compliant.

It is recommended the agency revise the PREA policy to include all of these required monitoring components.

(b) The Agency Head, Director, and Designated Staff Member Charged with Monitoring interviews indicated that multiple protection measures would be employed for resident victims of sexual abuse. These protection measures would include housing changes, transfers, removal of alleged abusers from contact with the resident victim. In addition, emotional support services are available through the Pathways agency for residents and staff who fear retaliation for reporting sexual abuse and/or sexual harassment and those who cooperate with abuse investigations.

The Pathways agency PREA policy includes housing changes or work assignments for protection measures, it is highly recommended that the policy be revised to include all the components of this section.

(c) The Pathways PREA policy directs that for at least 90 days following a report of sexual abuse the agency shall monitor the treatment of residents and staff who reported sexual abuse. This policy does not include those who were reported to have suffered the sexual abuse.

It is recommended that language from this section of the standard be added to the agency PREA policy.

(d) The Designated Staff Member Charged with Monitoring Retaliation interview indicated that resident monitoring would include periodic status checks. The facility uses a form that ensures periodic status checks is completed and documented.

- (i) The Pathways agency maintains all PREA written investigations indefinitely. It is recommended that language from this section of the standard be added to the agency PREA policy.
- (j) The Pathways agency PREA policy directs that the departure of the alleged abuser or victim from the employment or control of the facility would not stop an investigation of sexual abuse and/or sexual harassment. This is also supported by the facility investigators responses.
